Explanation of Fees and Levies

| School Fees: | School Fees assist in covering costs associated with the everyday operations and running costs of our school. In addition, they cover the Archdiocesan Education Levy paid to the Archdiocese by all BCE schools. Together with government funding, this provides for staffing and the functioning of all BCE schools, offices and service centres. |
| Capital Levy: | This levy is NOT tax deductible. It is a compulsory levy used to assist our school fund its capital expenditure program including the financing of loans when required. It also covers regular maintenance and upkeep of all our school facilities. |
| General Levy: | This levy covers the cost of technology resources (NOT purchase of Classroom iPads or Laptops) and their maintenance, excursions, student activities including transport, classroom resources, school buildings and ground maintenance as well as associated consumables. |
| P&F Levy: | This levy ensures that there is an equitable contribution of all families to the activities of the P&F in support of our school. It, combined with monies raised through P&F fundraising events, finances the initiatives that aid development of facilities and resources of the school. |
| Prep Resource Levy: | This levy covers a variety of additional costs associated with the education of our prep students. Such costs include classroom and subject specific resources and consumables. |
| IT Equipment Levy: | This levy covers the purchase of classroom iPads or laptops based on BCE's 3 year replacement program. Also included is the cost of warranty for an additional 2 year period and protective cases. |
